In November 2024, 430 RASFF notifications were published. You can find the evaluations as usual under point 1 of this newsletter.


An implementing Regulation on metribuzin was published in the Official Journal of the European Commission (point 2).

# 1. Notifications in Safefood-Online: November 2024

Compared to October, the number of new RASFF notifications is in November at a significantly lower level:

- **November 2024:** 430
- Oktober 2024: 531
- September 2024: 338


The notifications from November 2024 are divided as follows:

- Alert notifications: 100
- Border rejections: 132
- Information messages: 198



In November 2024, the product category fruit, vegetables and pulses ranked first with 92 notifications, followed by nuts, seeds and products made thereof (72 notifications). Cereals and bakery products are in third place with 42 notifications. In the category fruit, vegetables and pulses product category, 42 notifications are related to pesticide findings and 36 notifications to mycotoxins. Nuts, seeds and products made from them received the most notifications due to mycotoxins (38) and pathogenic micro-organisms (15):


## RASFF-Notifications November 2024: Top 10 product categories



# 1. Notifications in Safefood-Online: November 2024


As in the previous month, dried figs are ranking first in the evaluation by products with 33 notifications. All notifications concerned mycotoxin findings. Sesame seeds followed in second place with 17 notifications, 11 notifications due to salmonella. Peanuts are in third place with 16 notifications. With one exception, all notifications concerned aflatoxins:

## RASFF-Notifications November 2024: Top 10 products




In the evaluation by hazard category, pathogenic micro-organisms were in November again in first place with 117 notifications, followed by mycotoxins with 86 notifications (including 20 notifications due to chlorpyrifos findings) and pesticides with 69 notifications, mainly for dried figs, peanuts and pistachios:

## RASFF-Notifications November 2024: Top 10 hazard categories




# 1. Notifications in Safefood-Online: November 2024

In terms of hazards, Salmonella remained in first place in November with 79 notifications, followed by aflatoxins with 61 notifications and Chlorpyrifos with 20 notifications:



Finally, the evaluation of the notifications according to the country of origin of the products:



Türkiye is in first place with 65 notifications, followed by Poland and Italy with 27 and 25 notifications.

## 2. Update on pesticides and contaminants



### Commission Implementing Regulation (EU) 2024/2806

With **Implementing Regulation 2024/2806**, the EU Commission has decided not to renew the authorization of the active substance metribuzin due to concerns about its endocrine-disrupting properties. The EU member states must withdraw the approvals for products containing metribuzin by May 24, 2025 at the latest.

## Food Fraud



## European Court of Auditors: Food labelling in the EU – consumers can get lost in the maze of labels (Special report 2024)



The European Court of Auditors has presented the **Special Report 2024 on food labelling in the EU** and concludes that food labelling within the EU can help consumers make informed decisions when buying food. On the other hand, according to Keit Pentus-Rosimannus, the member of the European Court of Auditors responsible for the audit, food labels often lead to confusion instead of providing clarity. The report emphasizes that overly cautious allergen warnings and vague statements such as “may contain” limit the choice of food allergy sufferers. Vegetarians and vegans are particularly affected, as there is still no EU-wide regulation for this area. The lack of nutritional profiles is also (still) criticized, as this makes it possible to make nutritional and health claims despite high levels of sugar and fat, for example
